Use *Form A* when contesting a Notice of Intent to Suspend Driver's License and Motor Vehicle Registration(s) For Nonpayment of Support

## FORM A

**Completion and submission of Form A is time sensitive!** You have **20 days** after the date the **Notice of Intent to Suspend Driver's License and Motor Vehicle Registration for Nonpayment of Support** was mailed to comply with the prior order. If you are unable to comply within that time frame, the suspension will go into effect, unless you take one of the following actions: (1) pay the delinquency in full and any other costs and fees accrued between the date of the notice and the date the delinquency is paid; enter into a written agreement for payment with the Obligee in non-IV-D cases or with the Title IV-D agency in IV-D cases; or in IV-D cases, complies with a subpoena or order to appear, order to show cause, or a similar order; or file a **PETITION (Form A)** with the circuit court to contest the delinquency action; and (2) pays any applicable delinquency fees. (If the Obligor in non-IV-D cases enters into a written agreement for payment before the expiration of the 20-day period, the Obligor must provide a copy of the signed written agreement to the depository or the Clerk of the Court. **IMPORTANT: The original copy of Form A must be notarized and filed with the Clerk of Court. A copy should be furnished to the Florida Department of Revenue-CSE, 115 S. Missouri Avenue, Suite 102, Lakeland, FL, 33815, and opposing party.**

Use *Form B* when contesting a Notice of Delinquency

## FORM B

**Completion and submission of Form B is time sensitive!** You have **15 days** after service of the **Notice of Delinquency** to file with the Clerk of Court a **MOTION (Form B)** to contest the impending judgment. An Obligor may contest the impending judgment only on the ground of a mistake of fact regarding an error in whether a delinquency exists, in the amount of the delinquency, or in the identity of the Obligor. **IMPORTANT: The original copy of Form B must be notarized and filed with the Clerk of Court. A copy should be furnished to the Florida Department of Revenue-CSE, 115 S. Missouri Avenue, Suite 102, Lakeland, FL 33815, and opposing party.**

THE TIMELY FILING OF A PETITION TO CONTEST STAYS THE NOTICE OF DELINQUENCY AND INTENTION TO SUSPEND UNTIL THE ENTRY OF A COURT ORDER RESOLVING THE MATTER. **PLEASE NOTE: IF YOU HAVE NOT RECEIVED A NOTICE OF HEARING WITHIN SIX (6) WEEKS OF FILING YOUR OBJECTION, PLEASE CONTACT THE SELF-HELP PROGRAM AT (863) 534-4015.**
